

PHARMACEUTICS

Pharmaceutics is the discipline of pharmacy that deals with preparation and evaluation of dosage forms viz. tablets, capsules, syrups, creams and ointments etc. It is also called the science of dosage form design.

India is world's pharmacy and Indian companies export medicines worldwide whereby they need assistance of regulatory affairs department. The Regulatory Affairs professionals job is to keep track of the ever- changing legislation all the regions in which the company wishes to distribute it's products.

PHARMACEUTICAL CHEMISTRY





PHARMACOLOGY

Pharmacology is the branch of biology concerned with the study of drug or medication action. It is the science of drugs and their effect on living systems. In another words it is the study of the body's reaction to drugs.

PHARMACOGNOSY

Pharmacognosy is the study about the physical, chemical, biochemical, and biological implications of natural products for medicinal or health benefit purposes. Pharmacognosy is the study of plants or other natural sources as a possible source of drugs. Laboratory is equipped with camera lucida, projection microscope, digital imaging system, extractors etc.

Pharmaceutical chemistry is the study of drugs, and it involves drug development process. It is disciplines at the intersection of chemistry, especially synthetic organic chemistry, and pharmacology where they are involved with design, chemical synthesis and development for market of pharmaceutical agents, or bio-active molecules (drugs). The instruments required for evaluation / analysis drugs are available in the department viz. UV-visible spectrophotometer, refractometer, polarimeter, photofluorometer etc.





MEDICINAL GARDEN

Medicinal plants, also called medicinal herbs, have been discovered and used in traditional medicine practices since prehistoric times. Herbal garden containing various medicinal plants is maintained in the institute premises in order to give practical knowledge to the students.



COMPUTER & LANGUAGE LAB

Keeping in view the increased emphasis on technology, the college has developed computer lab with broad band internet facility. The lab is equipped with sufficient number of computers with latest configuration and softwares. Separate language lab is developed for improving the communication skills amongst the students.

ICT ENABLED CLASS ROOMS:

All the classrooms are spaciously designed and are well furnished, well ventilated with necessary teaching aids like LCD projector, smart boards, white boards etc.

TRAINING AND PLACEMENT CELL

To boost up the confidence during studies in class room and laboratories, the students have to undergo industrial training. This activity is organized by students training and placement cell. This center is responsible for liaison with industries for getting good placement for students by arranging campus interviews.



LIBRARY & READING ROOM

Library has envious collection of requisite number of reference and text books as per syllabus. In addition to this thesaurus, encyclopaedias, pharmacopoeias, journals and periodicals are available in library. Digital library facility is available for all types of library transactions along with OPAC (Online Public Access Catalog) system for students and staff. Book bank facility is implemented for all the students. Library is also provided with DELNET facility. Spacious and comfortable reading room facility is provided. The library remains open from 8am. to 8pm. and extended during examination period.









AUDITORIUM

A central auditorium facility is developed by the management. This is well furnished, airconditioned and state-of-art multipurpose hall with seating capacity of 2000 people. The hall mainly used to host to guest lectures, seminars and various cultural activities.
